**ENTRY VISA REQUIREMENTS FOR REPORTERS AND MEDIA
REPRESENTATIVES****Dear applicant :**

Listed below please find the procedures for obtaining an entry visa for the Islamic Republic of Iran through this office.

You may submit the required documents via Express Mail to the above address to the attention of the Visa Section.

- 1- All applicable questions on the attached visa application form #103 must be completed entirely in English. Failure to do so may result in the rejection of your visa.*
- 2- Two recent passport size photograph, we cordially ask all female applicants age nine and above to respect Islamic dress code.*
- 3- A copy of your passport (page 1-3)*
- 4- Enclose a money order for the appropriate visa fee and postage (see the attached form #601). All other passport holders should call this office to inquire about the cost of the visa processing fee for your country.*

Your application will be forwarded to Ministry of Foreign Affairs of the Islamic Republic of Iran for further consideration. This procedure requires at least 25 days. You may contact us via telephone to Inquire regarding the status of your visa application. FOR EXPEDITIOUS PROCESSING, your business associate in Iran may apply for your visa directly at the Ministry of Foreign Affaris in Tehran.
